世界銀行集團的國際評級報告 World Bank Group's International Ranking Report

- 按照企業的開展、營運及結束業務,以評估各個經濟體營商環境的情況
 Measure economies' business environment from opening, operating and closing a business
- 為政府持續優化營商環境提供啟示
 Provide insights for government reform

在項目中獲取良好成績 Good Performance in Business Ready

- 對經濟體擁有法制健全、穩定、具透明度和高效的營商環境的肯定 Recognition to the economies with a legally sound, stable, transparent and efficient business environment
- 顯示在全球競爭中具備優勢,有助吸引投資、增強經濟的整體韌性和競爭力
 Showing the economies' edges in the international arena to attract investment and increase resilience and competitiveness
- 有利該地企業及相關專業行業的發展
 Conducive to the development of firms and related professional services

問題例子(監管框架) Question Examples (Regulatory Framework)

擁有和租賃物業的限制 Restrictions on Owning and Leasing Property

根據以下選項,是否有任何法例限制本地及海外公司擁有或租賃物業?

According to the regulatory framework, are there any restrictions on the following that domestic and foreign firms can own or lease?

- 土地面積 Area of the land
- 物業位置 Location of property
- 建築物高度 Height of building
- 租賃期限 Duration of the lease

工作場所歧視 Workplace Discrimination

法律是否明確禁止工作場所基於性別、 殘疾、種族和民族的歧視? Does the law explicitly prohibit workplace discrimination on the basis of gender, disability, race and ethnicity?

電子報稅 Electronic Filing of Taxes

Is an electronic filing arrangement on a tax portal available for corporate income-based taxes?



水務電子化服務 Digital Service of Water Supply

可否以電子方式為商業用途供水服務提交新申請?

Is it possible to apply for a new commercial water connection through a fully online process?

可否以電子方式繳交每月水費?

Is it possible to pay for the monthly water bill through electronic payment methods?

可否以電子方式繳交新供水申請的費用?

Is it possible to pay the fee for a new water connection through electronic payment methods?

What is the total time and cost to complete the entire company entry process for domestic/ foreign companies?

擬備、報稅及繳稅所需的時間 Total Time for Preparation, Filing and Payment

受訪機構就所有稅項(利得稅等)的擬備、報稅及繳稅每年所需的時間?

What was the total annual number of hours required for the preparation, filing, and payment of all taxes (profit taxes etc.) for the establishment in last fiscal year?
